**Ichigo J.League Shareholder Program Premium Present
Original Goods Commemorating Tegevajaro Miyazaki’s J2 Promotion**

Tegevajaro Miyazaki, owned by Miyako City, a subsidiary of Ichigo, Ichigo Hotel’s sponsor, was promoted to the J2 League after winning the 2025 Meiji Yasuda J2 Promotion Playoff Finals. Starting tomorrow, February 6, with the launch of the Meiji Yasuda J.League 100 Year Vision League, Tegevajaro Miyazaki will take on the challenge of competing on a new stage, the J2 League.

As an extension of its Ichigo J.League Shareholder Program, Ichigo is offering 30 shareholders the chance to win a special gift set commemorating the club’s promotion, including a limited edition Tegevajaro Miyazaki design Hydro Flask stainless steel tumbler, a tote bag, and clear files, via a lottery.

Ichigo Hotel will bear no expenses related to this special gift.



1. Special Gift Details

Two years ago, Miyako City acquired ownership of Tegevajaro Miyazaki, which was at the time ranked 19th in the J3 League. With the support of Ichigo, Ichigo Hotel, Ichigo Office, and Ichigo Green's shareholders, business partners, and the local Miyazaki community, Miyazaki Tegevajaro was promoted to the J2 League. To commemorate this promotion, Ichigo is offering Ichigo, Ichigo Hotel, Ichigo Office, and Ichigo Green's shareholders the chance to win original Tegevajaro Miyazaki goods via a lottery.

The gift set will feature the following three items. Please note that the design and color of the items cannot be specified.

- 1) Tote bag (Fire print or team mascot Jaro-kun print)
- 2) Limited edition Tegevajaro Miyazaki design Hydro Flask tumbler (Available colors: blue green, sax blue, black, and pink)

Tegevajaro Miyazaki

The club's name is a portmanteau of tege (meaning great in the Miyazaki dialect), vaca (Spanish for cow), and pajaro (Spanish for bird), in the hope that the team competes with the fighting spirit of a bull and soars to new heights like a bird. Dedicated to energizing Miyazaki through soccer, the club strives to be an indispensable presence for local residents. Ichigo became a uniform sponsor and supplier for the club in March 2019, and Ichigo's subsidiary Miyako City became the club's owner in December 2023.

Miyako City

Miyako City is a shopping mall that enriches the daily lives of Miyazaki residents. The mall is also a transportation hub for the Miyazaki City Bus Terminal used by c. 8 million people annually, and a hub for other public facilities including the headquarters of Ichigo Potager and Tegevajaro Miyazaki, and the Tegevajaro Miyazaki club house.
