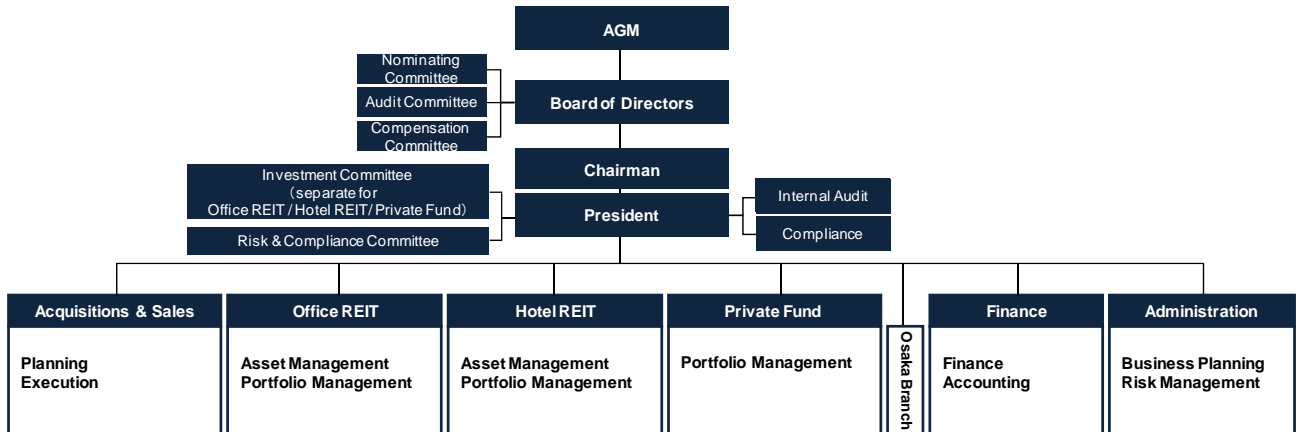

3. Organization

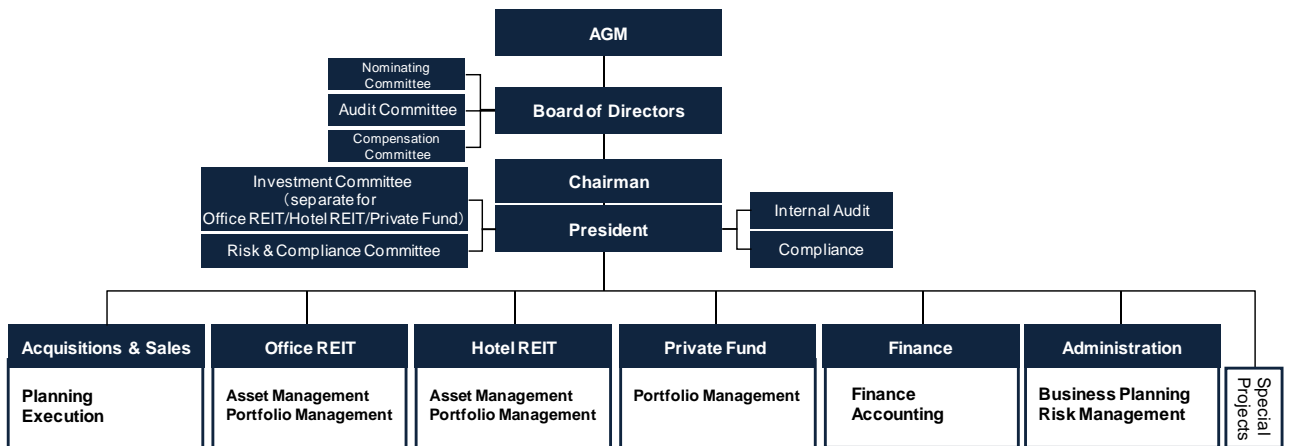
Effective March 1, 2016, IRE will establish a Special Projects team for new public offerings and abolish the Osaka Branch.
